

Center for Health Policy & Health Services Research 2024 Annual Report

The Center for Health Policy and Health Services Research (CHPHSR) at Henry Ford Health (HFH) continued its impressive growth in 2024. We look forward to another exceptional year in 2025, as we focus on sustaining partnerships and pursuing new ventures. Below, we highlight several of the major accomplishments from our team across our six divisions of work in 2024.

HEALTH SERVICES RESEARCH

The CHPHSR conducts leading health services and intervention research within our large healthcare delivery system. In 2024, our scientists and team members worked across a wide range of clinical and population health areas, including adult primary care, pediatrics, emergency medicine, women's health services, neurosurgery, quality and population health, oncology, orthopedics, psychiatry, and many others. The CHPHSR promotes research collaboration with leading health systems, universities, and other academic institutions across the country. As evidence of our efforts, CHPHSR has been a leader within Henry Ford's premier affiliation with Michigan State University, such as co-leading several large NIH-funded projects highlighted by our joint NIMH-funded P50 Suicide Prevention Center. Our team also remains core members in the Health Care Systems Research Network, a consortium of 19 healthcare systems across the nation dedicated to conducting embedded healthcare research. In 2024, this affiliation supported our participation in the NIMH-funded Mental Health Research Network and the NIDA-funded National Drug Abuse Clinical Trials Network.

In 2024, the Center investigators and staff were authors on 112 papers published in peer-reviewed journals and 62 presentations at regional and national meetings. Both accomplishments represent the largest single year totals in our history. Center investigators also received \$7.1 million in new awards from federal, foundation, and industry grants. Our research accomplishments are detailed in an accompanying *Appendix*.

As in prior years, CHPHSR team members led a robust portfolio of research. This past year our featured new grant was a 5-year NIMH-funded R01 project supporting a comprehensive study to develop and validate national quality measures for suicide prevention and care in United States healthcare systems. Dr. Brian Ahmedani serves as the overall Principal Investigator of the project, which also includes investigators and teams from the Washington and Colorado regions of Kaiser Permanente along with stakeholders from NCQA and The Joint Commission.

The Center was also involved in a range of other important studies. Among these new notable awards, Dr. Jordan Braciszewski received Flinn foundation funding to support development and implementation of an electronic safety planning intervention within school-based health clinics. Dr. Julia Felton received an NIH-funded R01 award to conduct a hybrid effectiveness implementation trial of a peer-delivered depression intervention. Expanding our portfolio in precision medicine, Dr. Hongsheng Gui also received an American Foundation for Suicide Prevention award to study poly-omic risk scores and suicide attempt.

Within Henry Ford, the CHPHSR remains a leader in facilitating partnered research. CHPHSR maintains active engagement with the Henry Ford Primary Care Research Institute. Team members serve the institution in leadership roles on the Henry Ford Medical Group Board of Governors, the Henry Ford Research Committee, the Promotions Committee, and the Neuroscience Committee. CHPHSR supported more than three dozen externally funded projects in partnership with other Henry Ford clinical departments.

We have continued plans to grow in 2025 as we pursue new and diverse lines for funding to support our expanding research program.

HEALTHCARE IMPROVEMENT

The Michigan Spine Surgery Improvement Collaborative (MSSIC)

2024 has been a year of transition, growth, and achievement for MSSIC. As we moved our Collaborative to a new registry vendor, we remained steadfast in our commitment to improving outcomes in spine care and addressing critical healthcare disparities.

One of the most significant and ongoing focuses for MSSIC is addressing disparities in spine care. Our data has consistently shown that African American patients and those living in disadvantaged neighborhoods experience worse surgical outcomes, including more complications, less pain relief, and lower rates of return to work. To tackle these disparities, the MSSIC Coordinating Center (CC) introduced an equity dashboard in August 2023, which was distributed to each MSSIC hospital. This dashboard provided hospital-specific outcomes, stratified by race and neighborhood deprivation. We emphasized that addressing equity is not a separate or competing quality improvement (QI) task but an essential component of improving overall care. In 2024, we built upon this foundation at the Abstractor Symposium, where we engaged participants in discussions about potential factors contributing to disparities, such as living alone, untreated depression, or undergoing emergent rather than elective surgery. The goal is to pinpoint factors that lead to significant disparities, which can then be targeted through QI initiatives. To support this effort, the MSSIC QI team developed and distributed a root cause analysis tool focused on ED utilization, which highlights specific risks contributing to disparities.

In addition to our equity work, MSSIC made significant strides in several other key areas. We exceeded our goal for opioid-naïve patients undergoing 1-2 level lumbar fusions who were discharged with 320 MME opioid dose or less. Preliminary MSSIC findings show no evidence of reduced patient satisfaction or increased healthcare utilization with decreased opioid prescribing. In fact, patients receiving fewer opioids were less likely to use opioids 90 days post-surgery.

While the development and implementation of Enhanced Recovery After Surgery (ERAS) is a significant investment of resources, our sites continue to show engagement and feel strongly that ERAS is the right thing to do for our spine surgery patients. We have seen the PDCA cycle applied to improve processes and make ERAS the standard of care at all MSSIC sites. The MSSIC Coordinating Center has provided extensive coaching support as sites make process adjustments where needed and risk assessments are implemented in the required areas of: Glycemic Control, Smoking Cessation, Opioids, Nutrition, and Anemia.

MSSIC successfully launched two new pilots: one focused on bone health and another on centralized pain management. In early 2024, the MSSIC QI team worked with Dr. Paul Anderson, Dr. Richard Easton, and Dr. Ilyas Aleem to develop the MSSIC Bone Health Risk Assessment tool. The team recruited 17 clinics for the pilot, and data collection began on November 1, 2024. Additionally, with guidance from Dr. Lara Zador, the MSSIC team adopted the Symptom Severity Index (SSI) and Michigan Body Map as our centralized pain risk assessment tool. Ten clinics were successfully recruited for this pilot, and data collection also started on November 1, 2024.

MI Mind Collaborative Quality Initiative

As the MI Mind Collaborative Quality Initiative (CQI) enters its fourth year of implementation, it continues to teach providers in primary care and behavioral health brief evidence-based interventions, such as suicide risk screening, safety planning, risk assessment, and lethal means counseling based on the Henry Ford Zero Suicide™ initiative. This collaborative effort currently includes 11 physician organizations, 124 practices, and 735 clinical providers, with plans to incorporate three additional physician organizations in 2025, further expanding its reach and impact. Recently, the collaborative-wide meeting featured Kevin Fischer, the executive director of NAMI Michigan and founder/CEO of "EVERYBODY-VS-STIGMA," who shared his lived experience and provided valuable insights into reducing stigma around accessing mental health services. In October, the program launched the "On MI Mind" webinar series, designed to augment the core zero suicide model curriculum with additional mental health and suicide prevention topics. Noteworthy webinars included a session on provider wellness from Dr. Lisa Maclean titled "The Healing Properties of Being a Provider," and a two-part series from Dr. Cathrine Frank, MI Mind program co-director and chair emeritus, covering advanced use of psychotropic medications for treatment of anxiety and depression. The series will continue in 2025 starting with Dr. Jordan Braciszewski who will cover how to leverage motivational interviewing to address suicide prevention in primary care.

Building on its commitment to expanding suicide prevention efforts, the MI Mind team adopted a two-pronged approach to support participating physicians and their communities, aiming to make suicide prevention

a societal priority. As part of this effort, MI Mind actively engaged in local events such as Motor City Pride, NAMI Walks, and AFSP's "Out of the Darkness" walk to raise awareness about mental health and provide suicide prevention resources. Highlighting the program's impact, Julie Arnold from Holland Hospital shared, "MI Mind helped us make sure our staff are educated and that we are all utilizing the same approaches to identify suicide risk with every patient, every time. Starting from the initial contact with a medical assistant and continuing to the provider, the training and protocols have made our practices more consistent." Through these combined efforts, the program continues to strengthen its network and improve suicide prevention outcomes across Michigan.

Overall, this past year the Center received multiple Federal and Foundation grants to support implementation of evidence-based services in several clinical areas, including within primary care, pediatrics, emergency medicine, women's health, and autism care. In total, the combination of several large quality programs along with other foundation funded initiatives support a large body of work in healthcare improvement across the Center. Our team continues to look forward to growing this area over the next several years as our overall team continues to take on a larger role in important areas of healthcare.

EDUCATION AND TRAINING

The Center's Education and Training Core provides mentoring and a supportive structure for trainee growth across several areas including post-doctoral research fellows, psychiatry residents, medical/graduate students, social work interns, undergraduates, and clinical psychology interns and fellows. In 2024, Center staff provided research and/or clinical education and training to 95 trainees at various levels of education. The cornerstone of these efforts resides in our National Institute of Mental Health-funded T32 Training Program in Mental Health Services Research. In addition to leadership provided by Dr. Ahmedani (PI) and Dr. Braciszewski (Training Director), each Center scientist contributes to the success of the T32 through direct mentoring of trainees and/or conducting seminars during our weekly "Academic Thursday" series. Our T32 program is in its fourth year of funding and provides training to two first-year fellows and two second-year fellows simultaneously. Our first-year fellows, Drs. Mason Breitzig and Carlisha Hall were selected and began working in our fellowship in summer/fall of 2024. We are delighted to have them in our program, following a very competitive application process. Indeed, the quality of applications continues to rise, as all candidates had significant publication and grant funding records. Our second-year fellow, Dr. Erin Haley, made outstanding progress on her training plans over the last year. In 2024, she published several papers, presented at the Henry Ford Health Research Symposium, and submitted a K23 award which received a very favorable review and may be competitive for funding upon resubmission. Our T32 program continues to expand in its national recognition, as we received 15 very competitive applications from across the country for our 2025-2026 cohort and are excited to work with our two incoming fellows for next year.

In addition to the T32, several of our faculty members (led by Dr. Ahmedani as Director of Psychiatry Research) provided mentoring and training opportunities to psychiatry residents. Dr. Ahmedani taught a fourweek course in research methods to all PGY1 students, while Dr. Braciszewski provided a six-week training in Motivational Interviewing to all PGY3 residents. Center faculty provided research mentoring to all 24 psychiatry residents, 6 of whom contributed to papers and 7 of whom were presentation authors in 2024. Center scientists also provided research mentoring to 11 Wayne State University and 11 Michigan State University medical students, 6 of whom contributed to papers and 12 of whom were presentation authors. Dr. Braciszewski also participated on 2 dissertation committees at Wayne State University. Center faculty provided direct research mentoring for 4 graduate students and 5 undergraduate students, 3 of whom published manuscripts. In addition to various lectures provided by Center scientists across and outside of the health system, Dr. Alyssa Vanderziel again participated in the RYSE MED cohort of high school students seeking careers in medicine and research. Dr. Vanderziel assisted with the training of 3 students from backgrounds traditionally underrepresented in the biomedical sciences, orienting them to careers in epidemiology and health services research. For this work, she received the Henry Ford Health RYSE MED Equity Through Mentoring Award, honoring her excellence as a mentor in this program. Dr. Braciszewski was nominated by 12 colleagues and mentees and received the award for Mentor of the Year from the Health Care Systems Research Network. Finally, Dr. Lisa Matero led Henry Ford's APA accredited Clinical Psychology Internship Program and the Clinical Health Psychology Fellowship. In

2024, these programs served 23 trainees (across two academic cohorts), 6 of whom contributed to papers and 6 of whom were co-authors on presentations with Dr. Matero. Dr. Matero additionally provided clinical supervision and didactics for these 23 trainees. These two programs continually attract candidates from across the country, as Dr. Matero has created experiences that are highly unique among such training programs.

Dr. Ashlee Vance was awarded a 3-year R25 training grant entitled, "A Nursing Program for Advancing Training in Health and Social Determinants (N-PATHS)." Through a competitive application process, select nurses and other allied health professionals take part in a 9-month comprehensive research training program grounded in community-based, participatory research. Specifically, chosen applicants complete monthly learning modules (asynchronous) and webinars (synchronous), an intensive in-person 4-day workshop, and regular mentoring related to their research projects. The overall objectives of the program are to: 1) Enhance participant knowledge and understanding of SDOH frameworks and concepts, 2) Strengthen participant's capacity and skills to apply SDOH concepts in the design, analysis, dissemination, and implementation of research, 3) Expand the volume and quality of nurse-led research focused on health equity and SDOH through dissemination of research findings. After a 6-month development period in 2024, Dr. Vance and her team are ready to open the application process in early 2025.

GLOBAL HEALTH

The Center's Global Health program expanded substantially in 2024. The Center hosted the 5th Zero Suicide International Summit in Liverpool, England in partnership with Henry Ford's Behavioral Health Services and Global Health Initiative as well as NHS Mersey Care in England. The Summit brought together more than 110 stakeholders from 25 countries representing 6 continents. The Summit was highlighted by introductory remarks from HRH The Prince of Wales in England and included sessions focused on individuals with lived experience, workforce suicide prevention, innovative technologies, and zero suicide opportunities in low- and middle-income countries. In commemoration of the event, the city of Liverpool lit all the governmental buildings in orange.

Our Zero Suicide International programs continued to expand in 2024. Joslyn Westphal, MPH, was named Director of Operations for the initiative demonstrating our strong commitment to substantial growth in suicide prevention. Zero Suicide International will now support our entire portfolio of suicide prevention activities. This includes our NIMH funded R21 grant, which seeks to develop implementation strategies for suicide prevention among youth in Nepal. As a demonstration of our work, the team hosted a large stakeholder meeting in Nepal featuring representatives from various business sectors along with leaders from the Ministry of Health, World Health Organization, and UNICEF. Dr. Brian Ahmedani presented at the Asian Federation of Psychiatric Associations International Conference in Abu Dhabi in June, while Dr. Jordan Braciszewski presented grand rounds for Nepal's Patan Hospital in October. The team also presented at the Mental Health Conference in Bogata, Colombia. Zero Suicide International leadership published an invited commentary manuscript highlighting their ongoing and planned activities across Asia within the Asian Journal of Psychiatry.

Locally, our team continued its work on our State of Michigan grant partnering with community organizations across Michigan to develop and pilot test an adapted version of Henry Ford's Zero Suicide™ Model for refugee populations. The project generated new evidence to support the feasibility and acceptability of the model, which will be used to inform wide-scale implementation efforts. Moving forward, we anticipate initiating new work with key partners in countries around the world and throughout the US.

HEALTH POLICY

The Health Policy team includes Diane Valade, Director; Alex Donnelly, Manager; Lauren Lambert, Manager; and Hassan Kourani, Health Policy Analyst, as well as policy researcher David Nerenz, PhD, Director Emeritus and Research Scientist. The Health Policy team provides incisive analysis of healthcare policies to guide the health system's policy and advocacy priorities and engagement at the federal, state, and local levels. The team works closely with Henry Ford Health's Government Affairs (GA) office, as well as key internal stakeholders and Health Alliance Plan, our health plan subsidiary, to inform policies that impact the health system and the patients and communities we serve. Our work includes monitoring, analyzing, and summarizing state and federal legislation and regulations, working in consultation with subject matter experts throughout the health

system to assess the impact of proposed policies on Henry Ford Health's costs and operations. Every year, we provide four quarterly health policy reports, linked to the GA newsletter, that review all state and federal bills and regulations tracked over that period.

At the state level, we tracked over 200 state bills and provided comments on state Medicaid regulations related to group prenatal care and chronic disease reporting. We also provided 340B Drug Pricing Program (340B) talking points for use by GA as they provided testimony on the importance of a 340B contract pharmacy bill. We continue to support policy issues related to Community Health Worker reimbursement, improved inpatient psychiatric care reimbursement, workforce issues, and more.

At the federal level, we tracked over 100 federal bills, provided comment letters on nine federal regulations, including the annual Centers for Medicare and Medicaid updates, and responded to a bipartisan Senate Request for Information on 340B. We reviewed draft federal legislation on individuals dually eligible for Medicare and Medicaid, which impacted the Program for All-Inclusive Care for the Elderly (PACE). We also developed talking points for leaders to help defend against the passage of detrimental site-neutral payment policies that Congress was considering. And finally, in advance of the Presidential election, we provided an analysis of the healthcare positions of the two candidates and the potential impact on our healthcare system. Henry Ford Health, due to the combined efforts of the GA and Health Policy teams, had several victories at the state level this year. The state budget included full funding for the Michigan Medicaid program, including increases to provider reimbursement in line with the average commercial rate, as well as other key healthcare priorities such as funding for school-based health centers, the program for all-inclusive care of the elderly (PACE), maternal health programs and peer recovery coaches.

The policy research staff lead or participate in publication of influential policy research papers in leading medical or health policy journals. Recently, Dr. David Nerenz, in collaboration with CHPHSR biostatistician Jianhui Hu, PhD, completed a set of analyses on the use of expensive cancer chemotherapy drugs by 340B hospitals; these results were presented at a national 340B policy meeting in Washington, DC and will be published in an upcoming issue of *BMC Health Services Research*. The policy research staff also participate in key federal and state committees. Dr. Nerenz serves as a member of the National Quality Forum Provider Group Stakeholder Advisory Panel and as a member of the Disparities Standing Committee and has served recently as a consultant to US News and World Report for their rankings of Medicare Advantage plans. He is also a member of the Centers for Medicare & Medicaid Services (CMS) Health Care Payment Action Learning Network (HCP-LAN) and the CMS Hospital Harm Technical Expert panel.


VALUE BASED CARE

The Center continued its division focused on Specialty Value-Based Care in 2024. In partnership with Dr. Charles Day – System Medical Director for value-based specialty care and Deedra LaPointe – System Administrative Director for value-based specialty care, the team maintains the journey to improve healthcare at Henry Ford and around the country by focusing on new ways to improve the quality and cost of care with our specialties. The long-term goal of our unique venture is to develop innovative value-based care models to support the highest quality care at the lowest cost within all of our Henry Ford medical specialty departments serving as a model for other health systems across the nation.


In 2024, the team worked on projects with multiple specialties, including orthopedics, heart and vascular, neurosurgery, transplant, oncology, orthopedics, and otolaryngology. The projects focused on key opportunities in value for specialty care such as minimizing variations of care, looking at optimal site of surgery, and indications for surgery or non-operable interventions. The team also partnered with Finance to hire a Financial Consultant it continues to expand. For 2025, the team plans to further expand resources, add additional specialty partnerships, and continue operationalizing interventions with specialties that improve value. The team also will continue submitting grant applications to fund innovative new research and innovation as well as disseminate their work through teaching/education, scientific manuscripts, thought papers, and presentations at leading national societies and venues.



Strategic Development of a Suicide Prevention Research and Implementation Program

Project Goals: This project will develop a strategic plan, including business and work plans, mission, vision, and short/long term goals, for a Suicide Prevention Program. It will develop research strategies generating new innovative care models and clinical implementation approaches to improve evidence-based care delivery through Henry Ford Health and a network of large health systems as well as low resourced and non-traditional health settings. This work will inform policy and advocacy efforts locally and nationally.

Quality Measures to Advance Suicide Prevention and Care Across Health Systems

Project Goals: As health systems continue to implement the Zero Suicide Model, it is necessary to develop adequate quality measures to facilitate rapid cycle quality improvement and benchmarking with the goal to improve suicide prevention care and reduce suicide. While initial quality measures have been developed by national accreditation and quality organizations, there remain opportunities for significant improvement. This study fills these major gaps through a series of three Specific Aims, including 1) To develop and test a set of suicide ideation and attempt (fatal and non-fatal) <u>outcome</u> measures, 2) To develop and test suicide care process measures to determine their impact on outcomes, including measures for suicide risk screening, risk assessment, safety planning, and specialty follow up care, and 3) To disseminate and optimize these measures via consensus meetings with the National Committee for Quality Assurance (NCQA), The Joint Commission (TJC), other professional organizations, and patient and health system stakeholders.

Implementation Strategies for Suicide Prevention among Youth in Nepal

Project Goals: The overall goal of the proposed R21 project is to work in partnership with stakeholders to develop implementation strategies for adopting suicide prevention approaches among youth in Nepal. The specific aims are to 1) Examine the feasibility of evidence-based suicide prevention approaches for youth in Nepal via stakeholder surveys and interviews, and 2) Develop and evaluate implementation strategies for prevention and intervention among youth at risk for suicide through a multi-step process informed by focus groups with key stakeholders. Stakeholders will include national and local government leaders, community organization staff, administrators and clinicians at hospitals and health clinics, school personnel, parents and youth. The proposed project will generate data to inform a future hybrid trial of the proposed implementation strategies and the design of a national suicide prevention strategy in Nepal.

Implementing an Electronic Safety Plan Intervention for Pediatric Primary Care

Project Goals: Suicide is the second leading cause of mortality among adolescents, accounting for more than 1 in 10 deaths per year. The Safety Planning Intervention (SPI) is a standalone intervention for increasing self-help behaviors among individuals who are unable to readily engage with mental health services. Although the SPI

exhibits clear efficacy, barriers such as workflow disturbance, staff training, and ongoing fidelity hinder implementation across general healthcare settings (e.g., primary care). The program seeks to implement a technology-driven SPI (eSPI, hereafter) in pediatric primary care at Henry Ford Health. We will achieve this through (1) collaboration with key stakeholders (e.g., youth, parents, leadership, clinicians, and staff) who will provide comments on clinical workflow, sustainability, and other factors related to the successful implementation of the eSPI and (2) rigorous evaluation of the implementation using the Plan-Do-Study-Act approach to quality improvement.

Project Goals: The current project leverages a unique opportunity to create a training model for improving access to mental health resources for youth in the Upper Peninsula. As part of this project, Dr. Felton will oversee training advanced practice providers and medical staff in a brief, evidence-based treatment for depression (Behavioral Activation), provide ongoing supervision and support for implementation of this approach, and assist Dr. Alavi in all other aspects of project implementation. Given her strong background in training non-mental health specialists in Behavioral Activation and role as a child clinical psychologist, she is well-suited to support this work.

Hybrid Effectiveness-Implementation Trial to Evaluate a Scalable, Peer-Delivered Intervention for Depression among People with Substance Use Disorders in a Certified Community Behavioral Health Clinic

Project Goals: Low-income, racial/ethnic minoritized individuals have limited access to evidence-based interventions for mental health, especially Black adults living in low-income areas. Peer recovery specialists, individuals in recovery from mental health and/or substance use problems, may have potential for increasing access to evidence-based interventions for Black individuals from low-resource communities, particularly when trained and supervised in models that are acceptable and feasible in these communities. By evaluating a peer-delivered evidence-based behavioral intervention, and how well it could be sustained, findings may have the potential to significantly improve access to mental health treatment in traditionally underserved communities.
